3. Upon receipt of the application, Bono and Associates will submit the ARC application to the association. A decision by the association may take up to **30 days**. Homeowner will be notified when the application is either approved, denied, or needing more information.
4. If the application is approved, the work must be completed within 30 days of the approval being mailed. If for any reason the paint is not completed within this deadline the homeowner must notify the Bono and Associates staff or the Fieldstream Architectural Review Committee. A new application must be submitted if the paint work is not completed within the 30-day timeframe.
